

## LICENSE AGREEMENT

Fundacja dla Rodziny with its registered office in Oława (55-200), Poland, located at ul. Wiosenna 2 lok. 5, entered into the Register of Associations of Polish National Court Register (Krajowy Rejestr Sądowy) under the KRS number 0000703941, National Business Registry Number (REGON): 368744847, Polish tax identification number (NIP): 9121912822, registry court: District Court for Wrocław-Fabryczna in Wrocław, IX Commercial Division of National Court Register, is hereby "the Licensor."

The following License Agreement stipulates the ways in which Fundacja dla Rodziny with its registered office in Oława, that is the Licensor, grants you, "the Licensee", the right to use the Records mentioned in § 1 of the Agreement.

### § 1 The Records

### § 2 The License

1. You may use the Records mentioned in § 1 of the Agreement on the conditions specified in this Agreement (The License).
2. The License we grant is non-exclusive, which means that also other persons may use the Records under the conditions specified in this Agreement.

### § 3

#### **Temporal and territorial limitations**

1. The Licensor grants the License to use the Records mentioned in § 1 of the Agreement without territorial limitations.
2. The License is granted for an indefinite period of time.

### § 4

#### **Fields of exploitation**

1. The Licensor grants the License to use the Records mentioned in § 1 of the Agreement within the following fields of exploitation:
  - a. public performing (in particular during masses, devotions, church services, prayer meetings, worship, concerts), presenting, exhibiting, displaying, playing, broadcasting and re-broadcasting the Records, as well as sharing the Records publicly in such manner that everyone can access the Records at the time and place of their choice, except for using the Records in television and radio programs.
2. The Licensor, within the scope of this Agreement, does not give consent for recording (e.g., on CDs) or reproducing the Records, nor for any trade thereof.
3. The Licensee is obliged not to draw any material gains from the usage of the Records.
4. Collection of donations for charity/social purposes is not regarded as drawing material gains.
5. The Licensor prohibits any modifications or alterations of the Records.

### § 5

#### **Charges**

The License to use the Records within the fields of exploitation specified in § 4 of the Agreement shall be granted free of charge.

### § 6

#### **Final provisions**

In matters not governed by this Agreement, the generally applicable Polish law shall apply.
